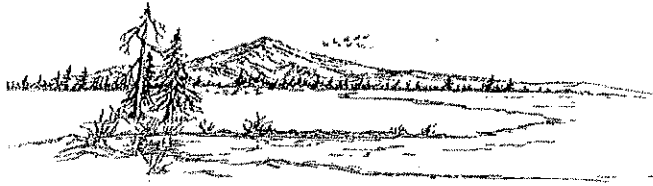

To the Shasta County Board of Supervisors:

The Fall River Resource Conservation District (FRRCD) supports the Fall River Valley Fire Protection District's (FRVFD) efforts to annex the areas of Day Road, Dee Knoch Road, and a portion of the McArthur Swamp in order to maintain and improve fire protection to these areas. Additionally, we support the FRVFD's efforts to secure the existing property tax revenues allocated to fire protection from these areas to support that service. The FRRCD has previously submitted a letter of support for the FRVFD and our position has not changed on the subject. We believe it is vital that our local fire protection district be responsible to respond to a fire and receive the tax revenue from the base it supports. As the majority owner of the McArthur Swamp, we are concerned with adequate fire suppression resources and expect the Board of Supervisors to place this as a high priority for our area.

It is our understanding that the Board of Supervisors previously adopted a position that despite fire protection service in these areas transferring to the FRVFD, 100% of the existing property tax revenue for fire protection would be retained by County Service Area #1 (CSA #1, AKA Shasta County Fire). As a special district in eastern Shasta County, we believe the County should follow the principle that the revenues follow the responsibilities—that is, whoever is providing a given service to our residents should also receive the existing property tax dollars for that service; in this case, the FRVFD, who is clearly in the best position to service these areas. If the Supervisors plan for our property to be supported by the Shasta County Fire Department then to that end we require the presence of engines and staff to accomplish this task. Thank you for your time in reviewing this critical topic and we ask that you reverse your prior position regarding the tax revenue and the proper assignment of it.

We also support the FRVFD's efforts to secure the existing property tax revenues allocated to fire protection from these areas to support that service. It is our understanding that the Board of Supervisors previously adopted a position that despite fire protection service in these areas transferring to the FRVFD, 100% of the existing property tax revenue for fire protection would be retained by County Service Area #1 (CSA #1, AKA Shasta County Fire).

As a special district in eastern Shasta County, we believe the County should follow the principle that the revenues follow the responsibilities—that is, whoever is providing a given service to our residents should also receive the existing property tax dollars for that service; in this case, the FRVFD, who is clearly in the best position to service these areas.

As the primary provider of emergency medical services in the Intermountain area, we believe the annexation of these areas and transfer of existing revenue to the FRVFD would also improve emergency medical response to portions of our hospital district. This would primarily be due to

- a) the closest fire resource being dispatched to assist our ambulance in these areas; currently, medical calls on Day Road or Dee Knoch frequently receive a fire response only from Shasta County Fire Department, which is much further from these areas than the FRVFD's fire stations, and
- b) the simplification of jurisdictional boundaries and associated dispatching of resources.



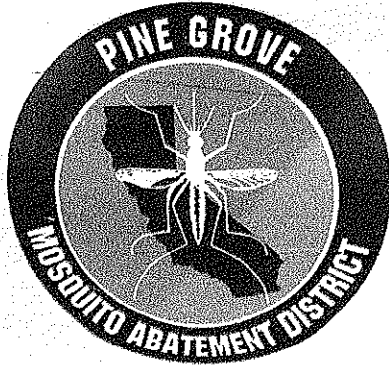
To the Shasta County Board of Supervisors:

We also support the FRVFD's efforts to secure the existing property tax revenues (ad valorem) allocated to fire protection from these areas to support that service. It is our understanding that the Shasta County Board of Supervisors previously adopted a position that despite fire protection service in these areas transferring to the FRVFD, 100% of the existing property tax revenue (ad valorem) for fire protection would be retained by County Service Area #1 (CSA #1, AKA Shasta County Fire). We find taking such a position is contrary to sound public policy. 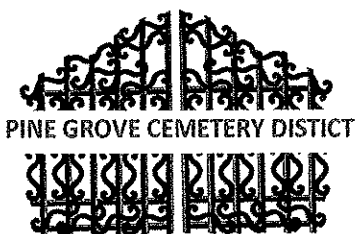



Dear Shasta County Board of Supervisors:

Day Lassen Bench Fire Safe Council is writing you in support of the Fall River Valley Fire Protection District (FRVFPD) and its efforts to secure a steady source of funding for the proposed annexation of the areas of Day Road, Dee Knoch Road, and a portion of the McArthur Swamp in order to maintain and improve fire protection to these areas. Day Lassen Bench Fire Safe Council, partnering with Lassen Fire Safe Council, has ensured significant fuel load reductions through grant-funded projects on the Day Bench area which is surrounded by Bureau of Land Management wildlands. Day Road will always have ingress/egress issues during a wildfire, which is why it is vital to ensure we have rapid response in case of a fire.

Having a funded and sustainable Day Road Fire Station is essential to the on-going safety of our area. As you can see from the map of the proposed annexation, the Day Road Fire Station isn't even within the boundaries of the current Fall River Valley Fire Protection District, yet the volunteers, all of whom already have full-time jobs and commitments, responded to seventeen calls on Day Road last year alone. The only vehicles at that station are a 1989 Pierce Type 1 4x2 Fire Engine and a 2009 Chevy 4x4 Patrol Truck. Despite the enormous risk of wildfire throughout the area, there is no water tender or fire engine/water tender stationed at Day Road due to lack of funding. If the annexation and the associated property tax revenues for fire protection are not approved, it is unclear if there are enough resources available to maintain the Day Road Station, let alone obtain some form of water tender to reside at that station.

Without a functional Day Road Station, call times would increase, and likely homeowners' insurance would be affected as ISO ratings are based in part on proximately to a fire station, as well as water supply. The ISO ratings for our area are already high and it would be a benefit to taxpayers to be able to reduce those ratings by funding the Day Road Station through the property tax and by funding a fire engine/ water tender.

The current District encompasses 54,505 acres in Shasta and Lassen counties and serves an estimated 2,000 people. However, their service area, where they routinely respond to emergencies, covers approximately four times that area, and includes portions of Modoc, Lassen, and Shasta counties, and the Modoc and Lassen National Forests. While it is our understanding that Shasta County has one fire station at Soldier Mountain, the entire area is protected by volunteer firefighters, who are our community members, and they deserve our support and funding for services and equipment. Their operating budget is less than \$200,000 a year, a small fraction of what Shasta County spends on its fire protection services. FRVFPD relies on property tax revenues for fire protection and also on grant funding, such as Shasta County Title III, for its survival. They are often the first responders to medical emergencies and fires in our area, whether it is in their district or not. They are a vital resource to our community and to Shasta County.

Day Lassen Bench Fire Safe Council not only supports the annexation as proposed with the commensurate property tax revenues, but also urges Shasta County to assist in the funding of a fire engine/water tender that would be stationed at the Day Road Fire Station to better protect our community.

Thank you for your consideration of this critical matter.

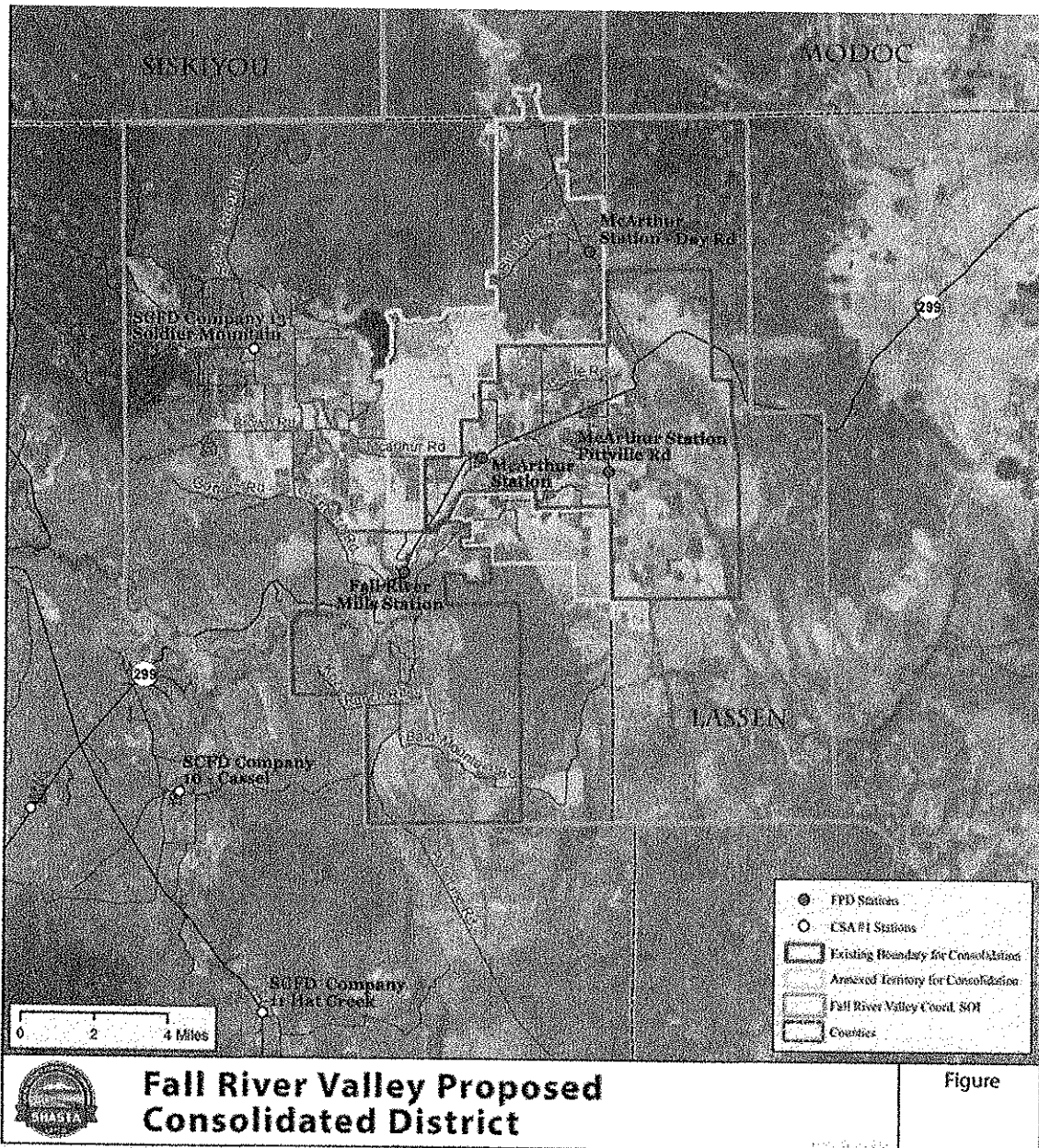

RE: Re-Distribution of Tax Dollars to Fire Districts

Dear Shasta County Board of Supervisors:

I am a sixth-generation landowner of the Dee Knoch Road area of Shasta County. For 84 years the Fall River and McArthur fire districts, now known as the Fall River Valley Fire Protection District, have provided service to our land. The purpose of this letter is to change the current distribution of tax dollars to the fire departments in our area.

My grandfather was one of the many firemen who donated not on his time and money, but also his blood, sweat and tears to help build the fire station in McArthur. He was one of the first Chiefs to serve the McArthur Volunteer Fire District. The station was built to serve a small community of tax-payers through fund-raising, donations and many volunteer hours. The station was the only means of protection for the community as the state provided no fire protection. Although Dee Knoch Road was not located in our district, the department has always protected this district because response times from the County fire stations are not manageable in the case of an emergency.

The Fall River Valley Fire Protection District (FPD) have been the first to respond to several medical emergencies at our ranch and their response time has been within the matter of a few minutes. Once on the scene, the men and woman have responded with true professionalism. Roughly 5 years ago a fire was sparked due to faulty electrical equipment and the McArthur Department was there and had the fire contained before it could spread to our hay barns. If Cal-Fire or Soldier Mountain had responded instead of McArthur, we would have lost over 500 ton of hay and 4-5 structures would have been lost or damaged. It is because of these hard-working and brave volunteer fire men and woman that many structures and land have been saved in our valley. It would only make sense that our tax-dollars would be used to fund the fire district that is closest to our area. The Fall River Valley FPD has the latest technology and equipment and with their short response time, has the capability to respond and contain any emergency in a matter of minutes compared to the long response time from a County or Cal-Fire Department.

In closing, I urge the Board of Supervisors to use our hard-earned tax dollars to support the Fall River Valley FPD. Their service to our community is essential and without the redistribution of our tax dollars, the fire protection of our small community could be in jeopardy.

We wholeheartedly support the Fall River Valley Fire District and know they are in the best position to provide fire protection to our property. It is our hope you have all had a chance to visit this unique rural area and are familiar with the geographic circumstances as well as response times should fire suppression service be required. Just to summarize and provide you an example of the fire service and response times to **45282 Dee Knoch Road** where we have two residences, crops, timber, livestock, and barns for premium hay storage:

Seconds count here and as a taxpayer we want our tax monies provided to the agency that will respond and be most effective in their service. Obviously, it will be either the fire service from McArthur or Fall River Mills. The Shasta County Fire Departments will do us little to no good and it does not make sense, nor can it be justified to invest in a service that will do so (due to the fact of proximity). I am writing this letter to you today regarding the funding of the Fall River Valley Fire District.

As a lifelong and multi-generational member of the Pittville community whose property is accessed from the Dee Knoch Road I am concerned about the present monetary funding situation of the Pittville Fire Station.

If I can have a few minutes of your time I would like to share the details of an experience I had.

Two years ago I found myself in a situation that required assistance from the local fire department. I was clearing several years accumulation of dead grass below my house and shortly after the fire was started the wind came up and I found myself in a situation beyond my control.

After a phone call to a member of the local fire department, it was within fifteen minutes a pickup with two volunteers were at the ranch and shortly thereafter trucks from McArthur and Fall River were onsite. The vegetation fire was quickly put under control and about the time it was all over with, Cal Fire arrived from the Johnson Park station. I suddenly found myself the center of attention.


The Cal Fire Captain was questioning the local Fire Department Chief about whose territory this was on. Cal Fire was saying forestry but the local Fire Department Chief pointed to the irrigation pivot in the field where they were parked and said this is ag land. As it turns out, I believe our property is in the Fall River Valley Fire District sphere of influence.

I appreciated the friendly, courteous, and professional response from the local volunteers. I apologized repeatedly for messing up their day but was met with responses like "it's good practice" or "it gives us a chance to run the equipment in a situation that is not life threatening"

I would like to close my letter to you with an appeal to you to put yourself in a situation like mine. If and when you find yourself faced with an emergency, I am confident you would prefer to know the closest help available to you is best equipped to handle whatever they are faced with.

With that said, I implore you to allocate to the Fall River Valley Fire District the portion of tax dollars that are withheld from my property taxes for fire protection.



We'd like to thank our local Fall River Valley Fire Protection District's continued effort to correct this attempt to misappropriate funding as our local fire districts work on a merger. How can Shasta County agree that this area would be better protected by merging these adjacent districts into one, but then not allow us to keep ALL the tax dollars paid by the landowners? Why should our dollars be used in Anderson? By merging the existing districts in our area, we can better utilize the few resources we do have and provide better and more timely training to our volunteers. This merger would also recognize the historic dispatch of calls which IS - local volunteer firetrucks arrive first.

We are a rural community that covers large expanses of land with few taxable assets. By keeping tax dollars from Day Road and Dee Knoch Road, it would appear Shasta County has "cherry picked" our most densely populated areas. It has been estimated the FRVFPD would add to its revenue about \$25,000 which would be 12% of its total budget. And while that \$25,000 is significant for us, it represents less than a rounding error in the county overall fire budget.

Help us improve our safety by supporting this merger and letting the fire district KEEP ALL the money for those areas it would take formal responsibility for.

Our Day Road Volunteer Fire Department is the most north east station covering a large area of land which Cal Fire deems as "moderate to very high risk" (2007 CAL FIRE "Fire Hazard Severity Zone"). With no local water tender and no fire hydrant system throughout the community of the Day/Lassen Bench or Oak Woods Estates there is consistent concern and necessity for portable water which is imperative for reliable and quick response time. Should we rely on the next closest station, McArthur Pittsville, the response time would take minutes we cannot afford.

As a representative of Oak Woods Estates, I support the FRVFD's efforts to secure the existing property tax revenues allocated to fire protection from these areas to support that service. It is our understanding that the Board of Supervisors previously adopted a position that despite fire protection service in these areas transferring to the FRVFD, 100% of the existing property tax revenue for fire protection would be retained by County Service Area #1 (CSA #1, AKA Shasta County Fire). I am a resident of Oak Woods Estates in McArthur and am writing in support of the Fall River Valley Fire Protection District's (FRVFD) efforts to unite the areas of Day Road, Dee Knoch Road, and a portion of the McArthur Swamp in order to maintain and improve fire protection to our local areas. And specifically, am requesting particular attention to our local Day Road Volunteer Fire Station for their local contribution and financial needs in order to best improve fire protection in our area.

Much of our community has worked diligently over the past year and half taking proactive measures in creating defensible space around homes and structures, with recognition and a huge thank you to the mastication project and those who signed up for the service. It is the cumulative efforts of the community which help to be proactive at best to prevent and be prepared for possible wildfire and one of those most important measures is accessibly to water, and mobile water at that. Please note that the Day Road Volunteer Fire Station does not have a water tender.

With no local water tender and no fire hydrant system throughout the community of the Day/Lassen Bench or Oak Woods Estates there is consistent concern and necessity for reliable mobile water which is vital for quick response time, and in turn, will likely help to improve the ISO ranking which will help homeowners twofold.

From the 2020 Day/Lassen Assessment Wildfire Risk Assessment Report conducted by the Firewise Communities/USA® recognition program as stated in the Introduction:

- *"The potential for catastrophic wildland fire has been recognized in the Day/Lassen Bench Community. Various efforts have been made over the years to reduce hazards on residential lots and state laws are followed regarding the creation and maintenance of defensible space on all lots with structures. Nevertheless, fire remains a priority safety concern throughout the community."*


Additionally noted in this report, Cal Fire rates their Fire Hazard and Severity Zones. This is their rating for our local area:

- *"Periodically, Cal FIRE reviews and updates its statewide assessment of general fire hazards within and near the State Responsibility Areas (SRAs). This assessment generates fire hazard severity zone ratings (FHSZ). The 2007 CAL FIRE "Fire Hazard Severity Zone" (FHSZ) map for the region rates most of the Day\Lassen Bench area as a High fire hazard risk area with surrounding areas in close proximity to the community rated from Moderate to Very High risk."*

For the many facts shared in my letter, I am humbly requesting funding for our Day Road Volunteer Fire Station with the utilization of existing property tax revenue retained for fire protection and it be put forth as a proactive measure for critically needed fire equipment and peace of mind for our local residence.
