This is reapplication as Fall River Valley FPD had previously filed an application that included annexation of territory in Lassen and Modoc Counties. That application was withdrawn. The current application is for territory in Shasta County only. Started Notice of Filing.

Application – Axner Annexation & SOI Amendment to CSA #8 Palo Cedro

Conducted initial review of proposed annexation of parcels at Deschutes Rd & Old 44 into CSA #8 - Palo Cedro. Both parcels are outside the CSA #8 Sphere of Influence, a SOI Update to include these parcels is being processed concurrently with annexation of territory. Started Notice of Filing.

Scheduled and attended April 27 Executive Committee meeting to discuss special Commission meeting and staffing services recruitment.

Staffing Coordination General Staffing Services, Noticing, and Staff Reports.

Presented staff reports for April 6 2023 Commission meeting. Agenda items included Special District Member election results and proposed FY 2023-24 Budget. In coordination with legal counsel presented Executive Officer FY Staffing Services RFP for Commission Action.

Responded to Cottonwood Water District out of area (District) service connection inquiry. Advised District that parcel seeking service within District Sphere of Influence, allowing property owner, or preferably District, to apply to LAFCO for a services extension outside District boundary, within SOI, in anticipation of future annexation. Responded to Redding Area Bus Authority Transit General Manager inquiry on service area boundary inquiry. Responded to Shasta County Senior Planner inquiry with information for out of area service extension.

Submitted District Draft of Clear Creek Community Services District MSR /SOI Update to the General Manager for review; Proposing SOI reduction where there's City of Anderson overlap due to broader services by the municipality. Received requested information from Anderson-Cottonwood Irrigation District, including Board of Director's terms of office dates along and the 2023 Water Service Application & Agreement.

Received information from Shasta County Public Works for CSA #14–Belmont & CSA #15 Lighting District. Updated MSR to reflect 2 CSA # 14 drainage areas in (Carberry St. & Long Leaf Ln.) and 30 separate areas for CSA # 15 Lighting. Updated CSA Map & table with lighting areas, acreage, parcels.
