Shasta LAFCO adopted the Fiscal Year 2020-2021 on June 4, 2020

DISCUSSION:

Since FY 2020-21 budget approval, there have been several expenditures incurred that need additional funding of \$77,004:

- Additional early payment of \$61,534 to CalPERS, total \$60,984 budget increase to be allocated from contingency funds
- Miscellaneous Legal Services increase of \$4,000 to cover Colantuano Highsmith Whatley expenses to be allocated from contingency funds
- PERL Legal Services (BBK Law) increase of \$11,520 to be allocated from contingency funds
- InfoTech- Website: increase of \$500 to be allocated from contingency funds
