Reviewed for completeness and advised CSD General Manager that Plan for Services still needed. Provided Plan for Services Template. Responded to community inquiries about independent fire protection district formation as option. Provided formation information, including community petition guidelines.

Pre-Application – Tierra Robles Planned Development

Received Tierra Robles Planned Development review and hearing notice from Shasta County including proposed service from existing Water District which, during periods of insufficient supply (drought related CVP allocation reductions), proposes to contract with another District (CSD) to buy water, conveyed through existing CVP transmission lines. Researched Project EIR by County and determined CSD would make portion of its CVP allocation available for transfer. Reviewed proposal & determined that transfer of untreated water not subject to LAFCo review.
