MINUTES

Special Commission Meeting May 19, 2022
Shasta County Board of Supervisors Chambers
1450 Court Street, Redding, California

(These minutes are not intended to be a verbatim transcription of the proceedings and discussion associated with the business on the Commission's agenda; rather, what follows is a summary of the order of business and general nature of testimony, Commission deliberation, and action taken.)

1. CALL TO ORDER

a. Chairman Fust called the meeting to order at 9:01 a.m. in-person at the Shasta County Board of Supervisors Chambers.

Present: Chairman Fust, Vice-Chairman Neutze, Commissioners Chimenti, Haynes, Morgan, and Russell. Alternative Commissioners Campbell and Ryness were in the audience.

Staff Present: Executive Officer George Williamson, General Counsel Jim Underwood, Office Manager Kathy Bull.

Absent: Commissioners Dacquisto, Jones and Alternate Commissioner Rickert.

b. Commissioner Russell led the pledge of Allegiance.

2. PUBLIC COMMENT

John Whitmer said issues with Fire Station 56 and Shasta County Fire Department has to do with lack of volunteers which need to be addressed.

David Monroe, with PATROL, shared concerns regarding the Tierra Robles formation of a district which planning has now switched to forming an HOA. Issues with water service is a concern.

3. AGENDA ADOPTION

a. Agenda Additions/Changes

General Counsel Underwood added a Closed Session item as an urgent matter under Item 6. Correspondence as 6.a. Closed Session– Potential Litigation. Documentation had been received just prior to the meeting with threatened litigation regarding a scheduled public hearing.

6. CORRESPONDENCE

a. Closed Session – Potential Litigation

The Commission entered Closed Session at 9:13 a.m. and returned into Open Session at 9:42 a.m. General Counsel Underwood stated there were no reportable actions.

7. SCHEDULED PUBLIC HEARINGS

a. Municipal Service Review/Sphere of Influence Update - Shasta CSD.

Mr. Williamson explained the Municipal Service Review and Sphere of Influence update is used as a baseline for the district prior to significant changes.

Chair Fust opened the public hearing. Fred Ryness, Alternate Commissioner said he would like to see more volunteers for the district as they are more personally knowledgeable of the area than CalFire.

Tom Carroll recommended the Commission not approve the resolution because it would split up the tax base with the fire service funds. Mr. Williamson explained the Shasta County Board of Supervisors passed a property tax revenue sharing resolution and the Shasta CSD Board did the same, should the fire divestiture move forward the property tax sharing agreements would go into effect, but this is a separate agenda item as 7.b. With no further comments, the public hearing was closed.

Motion to approve the MSR/SOI update as presented was presented by Commissioner Russell, seconded by Commissioner Neutze.

Amended Motion to approve the MSR/SOI update with changes made today via Resolution 2022-07 was presented by Commissioner Russell, seconded by Commissioner Neutze, and passed by the following votes:

b. Proposed Shasta Community Services District (CSD) – Fire Services Divestiture and Designation of County Service Area #1 – Fire as Successor Agency

Mr. Williamson provided information on the application filed by resolution from the Shasta CSD Board. Once the application was determined complete, a notice of filing was done. Once staff received resolutions for tax exchange agreements, a certificate of filing was completed, notice of public hearing and a special meeting was scheduled. This is the only application for the Commission's consideration. There have been phone calls with information given on how to file an application, however, there have been no other applications received regarding Shasta CSD.

Sean O’Hara, Cal Fire Shasta-Trinity Interim Unit Chief explained the differences with CalFire and Shasta County Fire Department. He also explained the costs to run fire station #56 and said the current station would have volunteers with no paid staff. Chief O’Hara also provided information on the complicated process CalFire would have to examine to ensure safety and compliance with California mandates. Corado Reginatto, CalFire Fire Captain/Training Chief provided the Commission with information on training volunteers.

Gary Kreep, Attorney, stated he had provided paperwork that is part of a lawsuit, with Shasta LAFCO named as a defendant, but has not been filed, and was a draft. He was putting the commission on notice, not in a legal sense but a practical sense. Fred Ryness, Alternate Commissioner suggested having a water district and a fire district instead of a community services district

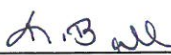
