WHEREAS, the Clear Creek Community Services District was formed in 1963; and

WHEREAS, the Executive Officer, pursuant to the Government Code Section 56000 *et seq.*, has prepared a municipal service review of this agency, and a proposed updated sphere of influence boundary recommendation based upon this analysis for the County Service Area Clear Creek Community Services District; and

WHEREAS, in the manner required by law, the Executive Officer has given notice of the public hearing by the Commission on the proposal; and

WHEREAS, the Commission has heard, discussed and considered all evidence for and against the proposal, including but not limited to, the Executive Officer's analysis and proposed conditions and recommendations, the environmental document, applicable general and specific plans, and all testimony, correspondence and exhibits received prior to or during this noticed public hearing, all of which are included herein by reference.

NOW THEREFORE, IT IS RESOLVED, DETERMINED AND ORDERED as follows:

1. The project before the Commission is a proposed update of the Clear Creek Community Services District's Sphere of Influence Boundary and acceptance of its related Municipal Services Review.

2. Shasta LAFCO, as the lead agency, circulated a Notice of Intent to Adopt a Statutory Exemption for this project, responded to written comments received during the review period and hereby certifies a Statutory Exemption pursuant to the California Environmental Quality Act (CEQA) (Section 21083 PRC & CEQA GC Section 15262) for the proposed update of its Sphere of Influence.

3. The Executive Officer applied for and received a No Effect Determination from the California Department of Fish & Wildlife for this project.

4. The Commission, pursuant to Government Code Section 56425, makes the following specified determinations based upon data within the municipal service review to update the Clear Creek Community Services District's Sphere of Influence Boundary:

A. Present and planned land uses in the area.

Shasta County designates much of the area served as rural residential, some

commercial, some agricultural, and oak woodland uses. The Shasta County General Plan and Zoning Ordinance establishes and enforces current planning and zoning uses permitted within the District and within its SOI boundary. This is a rural area, with community development either clustered around Countyapproved subdivisions or scattered about on secondary roads.

B. Present and probable need for public facilities; adequacy of services.

The District has ongoing capital improvement programs to maintain and upgrade service systems. Its Master Plan has been updated to accommodate additional growth needs and service connections.

C. Present capacity of the public facilities and adequacy of public services that the agency provides or is authorized to provide.

District facilities are adequate for current service needs. It has the capacity to serve the areas within the proposed sphere of influence boundaries, with extension of services tied to development of parcels.

Based upon the topography and some of the naturally defined boundaries, all of the areas included within the District and its sphere of influence can be efficiently serviced by District facilities through gravity flow delivery systems, the construction of new mainline extensions, storage reservoirs, and the addition of pump stations in a few areas of higher elevation. New development will be required to install new infrastructure at the time of construction.

Historically, the reliability of this water source has been excellent; however, it has been necessary to exercise conservation measures during extreme drought conditions. In general, the District's annual average water usage is approximately 25% of the total contracted amounts; therefore, the District has a substantial supply available for future use.

Regarding water treatment capacity, the Centerville CSD has a dedicated capacity of 25% in the treatment plant located at the base of the Whiskeytown Dam. The District owns this facility (the water treatment plant) and is responsible for the operation and maintenance of the Muletown Conduit while the USBR retains ownership. Centerville Community Services District is also responsible for 25% of the O&M of the Muletown conduit.

D. Existence of any social or economic communities of interest in the area if the Commission determines that they are relevant to the agency.

The District is located just west of the City of Redding and is served by the Happy Valley Fire Protection District, an independent special district that provides fire protection and emergency rescue services. The District shares interagency

agreements with a number of local, county, state, and federal agencies.

The Clear Creek CSD has a limited number of commercial, industrial, and public customers within its boundaries; the majority of customers served are residential uses. The City of Redding provides a major shopping and service industry hubs for local residents.

E. Present and probable needs of disadvantaged unincorporated communities (DUCs) within the area.

As identified earlier, the District service area may qualify as a disadvantaged unincorporated community (less than 80% of the state average) under certain circumstances.

Shasta County is in the process of undertaking a study of these DUCs throughout the county as part of their General Plan update and additional information should be available for an expanded analysis of this designation during the next MSR/SOI Update which will be due in 2019. This study simply identifies the first step in that process: that areas within the District may qualify as a DUC and will be evaluated as such in future projects.

5. The Executive Officer is hereby directed to complete Update proceedings, and to schedule the subsequent review and update, as necessary, of this Agency's municipal service review and sphere of influence boundary five years from this approval date as required by statute.

6. The Clear Creek Community Services District Sphere of Influence is hereby updated and approved as presented on the attached map.

Availability of water guides where development will occur. The District Five Year Plans are updated regularly and provides guidance for addressing the impacts of future growth.

C. Present capacity of the public facilities and adequacy of public services that the agency provides or is authorized to provide.

District facilities are adequate for current service needs. It has the capacity to serve the areas within the proposed sphere of influence boundaries, with the cost of extension of services tied to future service needs, such as development of parcels.

The District provides a critical access hospital including acute care, emergency, obstetrics, hospice, ambulance, radiology, laboratory, surgery, outpatient, would care, respiratory, cardiac rehabilitation, physical therapy, and long term care. The District service area is greater than the territory within its current boundaries; therefore the District is proposing annexation of the service areas outside its boundaries.

D. Existence of any social or economic communities of interest in the area if the Commission determines that they are relevant to the agency.

Local shopping takes place within the Intermountain area (mostly Fall River Valley and Burney), and the City of Redding provides a major shopping and service industry hub to the west for local residents. Residents in Modoc county visit Alturas, and those in Lassen County do travel to Susanville. Reno is another major shopping area for all residents. Some people regularly go to Klamath Falls for shopping as well.

The Redding Area Bus Authority (RABA) operates the Burney Express, a daily bus between Redding and Burney that accommodates citizens for travel to the valley for doctor appointments and major shopping. This bus currently is a one-day ride, leaving in the morning and returning at night. Expansion of this service to two or three trips per day would permit a great number of people to take advantage of RABA services. This is the only public transportation service within the Districts service area.

E. Present and probable needs of disadvantaged unincorporated communities (DUCs) within the area.

As identified in the MSR section, Mayers Memorial Healthcare District service area qualifies as a disadvantaged unincorporated community by virtue of its median income. Shasta County is undertaking a study of these DUCs as part of their General Plan update and additional information should be available for an expanded analysis of this designation during the next MSR/SOI update.

5. The Executive Officer is hereby directed to complete Update proceedings, and to schedule the subsequent review and update, as necessary, of this Agency's municipal service review and sphere of influence boundary five years from this approval date as required by statute.
